RE: WATER RATE INCREASE

Dear Water Customer:

Despite continuous efforts to control costs, Upper Saucon Township finds it necessary to increase water rates. This is the first such increase in approximately 12 years. The last rate change occurred in 1999. The new water rates became effective January 15, 2011, the beginning of the first quarterly billing period. Bills for water usage at the new rates will be sent to customers in mid-April.

The rate increase is the result of increases in operating costs including electricity, purification chemicals, water testing, and compliance reporting. In addition, new projects, system upgrades and regulatory changes have required additional investment in the water system to ensure a safe, reliable supply of drinking water. In determining the new rates, the Township has evaluated all operating costs, future capital projects, and offsetting revenues related to the water system and has set the new rates accordingly. Please note that water system revenues are applied solely to the water system and are not used for any other purpose.

Depending on household usage, customers may experience a quarterly increase in their water bills of approximately 30 percent. Examples of projected increases appear in the following chart.

Our study reveals that the new rate structure is consistent with the rates of other water suppliers in the Lehigh Valley. Below is a comparison of the Township's new water rates to those of other water suppliers.
